1. JURISDICTION

These events are ClubSport Advanced Hillclimb Events, promoted by the Pukekohe Car Club and proudly sponsored by Brian Best Contracting. Both events being held at Port Waikato-Waikaretu Road. Saturday Tarmac and Sunday Gravel.

The Meeting will be held under these Supplementary Regulations, the MotorSport NZ National Sporting Code and its Appendices and Schedules particularly Appendix Five, Schedule C being the Standing Regulations for all ClubSport Events and Appendix Two, Schedule A – Driver and Vehicle Safety Requirements.

3. EVENT DESCRIPTION:

3.1 The events will be as follows: Saturday - Port Waikato-Waikaretu Road, Port Waikato. This is a challenging Tarmac event approximately 5.7km in length with a combination of tight and twisty and faster flowing sections. Extended this year to due to Cyclone Gabrielle road damage close to the previous years start. Sunday – Port Waikato-Waikaretu Road, Limestone Downs, a gravel favourite of many. 4.2km in length, a faster flowing start leading into tight and twisty uphill section finishing off with a run along the crest of the hill into a deceptively tightening downhill corner on the finish.

Saturday's Event: Service Park will be situated in a paddock just before 401 Port Waikato-Waikaretu Road, with Documentation in the woolshed on the opposite side of the road.

Sunday's Event documentation and scrutineering will be held in the service paddock at Limestone Downs.

3.2 Classes: Vehicles will be divided into the following classes:

- (A) 0 – 1300cc
- (B) 1301 – 1600cc
- (C) 1601 – 2000cc
- (D) 2001 and over
- (E) 4WD
- (G) Cross Cars

4. ENTRIES:

4.1 Entries should be made through the MotorSport Online system (<https://possum.motorsport.org.nz>). Any entry will not be deemed valid until payment is received.

Entries will be accepted on the day of the event, up till 9.00am on each day. There will be no late entry fee incurred.

Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.

4.2 Opening and Closing Dates:

Entries open with the publication of these regulations and close at 9.00am on the day of the event.

4.3 Entry Fees:

4.4 Number of Starters: The maximum number of starters will be 50 with preference given to those that have paid prior to the event. Any additional entries received will be placed on the reserve list in order of receipt.

5. COMPETITOR REQUIREMENTS and UNDERSTANDING:

5.1 Licence Requirements:

All drivers must hold as a minimum an M Grade Competition Licence and current membership with a member club.

If the Entrant is other than a driver, an Entrants licence in the name of the Entrant is required.

5.2 Competitor Understanding:

In submitting the entry competitors (Entrant and Drivers) are deemed to fully understand the MotorSport NZ National Sporting Code and its relevant Appendices and Schedules. In particular:

- The National Sporting Code Articles pertaining to protests and competitors obligations, and Appendix Five - Clubsport, Schedule C - Clubsport.
- All Drivers must sign the CSport002a – Clubsport-Driver-Passenger-Ride-Declaration.
- Passengers may only be carried in accordance with Appendix Five, Schedule C Article 6.2.
- If carrying passengers all Drivers must sign the CSport002a – Clubsport-Driver-Passenger-Ride-Declaration.
- Drivers must brief all passengers on basic event safety procedures, how to wear and subsequently uncouple the safety harness.

- The minimum age of any passenger is 12 years. Passengers under the age of 16 must have a completed “Clubsport Event Indemnity and Consent Form” (MSNZ form CSport002) or a MSNZ Competition Licence stamped “Authorised Minor”. Form CSport002 can be downloaded from the MSNZ Website or will be available at the event. This is to be signed by a parent or legal guardian (not just the person taking care of them on the day)
- Any competitor who causes damage to Public Property, Pukekohe Car Club, or their Sponsor’s Property will be billed for the damage up to the excess of the Public Liability Insurance Policy in the name of Motorsport New Zealand Inc. (Note: current policy excess fo \$3,500)

5.3 All competitors shall wear safety apparel in compliance with Appendix Two, Schedule A.

5.4 **Fuel Handling:** Competitors are reminded about the Code of Practice for Motorsport Fuel-Storage and Handling. The full details of this Code is found here: <http://motorsport.org.nz/resources/safety-training/code-practice-motorsport-fuel>

5.5 There will be a reconnaissance run directly following drivers briefing.

5.6 Unofficial Practice or Reconnaissance on the venue prior to the event is PROHIBITED. The residents have been instructed to inform the event organiser and provide a description of the vehicle. If you are found to be doing this your entry will NOT be accepted.

6. ELIGIBLE VEHICLES

6.1 **Compliance:** All vehicles shall comply with Appendix Five Schedule C and Appendix Two Schedule A of the current MotorSport Manual unless stated otherwise in these supplementary regulations.

6.2 Rollcage: All cars must have a homologated safety rollcage compliant with Schedule A of the current Motorsport Manual.

6.3 Cross Cars must comply with Appendix 5, Schedule XC <https://www.motorsport.org.nz/wp-content/uploads/Schedule-XC-2021-Final.pdf>

7. DOCUMENTATION & SCRUTINEERING AUDIT INSPECTION

7.1 **Documentation:** Will take place at the venues commencing at 8:00am and concluding at 9:00am

7.2 **Scrutineering Audit Inspection:** Will take place at the venue commencing at 8.00am and concluding at 9.00am. Competitors will be advised at documentation if their vehicle has been selected for audit.

7.3 **Accident Damage:** Competitors are reminded that, in accordance with Schedule A Part 1, Article 3.4(8), if there is significant damage sustained, it is the Competitor’s responsibility to present the vehicle and Logbook to the Event Chief Scrutineer for inspection and notation of any applicable information.

7.4 **Drivers’ Briefing:** This will be held at the woolshed on Saturday and in the pits area on Sunday commencing at 9:30am. Attendance by all drivers is compulsory – a roll call will be taken and failure to attend may result in a penalty.

Passengers: Any passengers in cars for this event will also have to attend a passenger briefing to be held after the drivers briefings.

8. POSTPONEMENT CANCELLATION ABANDONMENT & ORGANISERS’ RIGHTS:

8.1 Pursuant to national Sporting Code Article 13, the organisers reserve the right to postpone or cancel the event.

9. OFFICIAL BULLETINS

9.1 Official Bulletins may be issued in accordance with the provisions of the National Sporting Code.

10. GENERAL INFORMATION

10.1 Alcohol is not permitted to be consumed by any competitor or their crew at the event before or during the day’s competition.

10.2 Strictly no dogs allowed.

10.3 **Prizegiving:** Will be held in the woolshed opposite the service park on Saturday and in the pit paddock on the Sunday as soon as possible after the event.

10.4 Accommodation: Accommodation is available at the venue on Saturday 23rd November at the Limestone Downs Accommodation Quarters, cost \$40.00 and the Woolshed Shearer's quarters, cost \$20.00 per person, bedding/linen and towels will be required. 10.5 Directions: Saturday

Directions from Tuakau

- Travel to Tuakau township, continue on River Road then turn off at Tuakau Bridge-Port Waikato Road.
- Travel around 25kms until you get to Port Waikato then continue on to Port Waikato- Waikaretu Road. Travel approx 7kms until you get to the woolsheds and turn right into pits.

Directions from Huntly

- Cross the bridge at Huntly and travel along Heatherington Road, pass through Rotongaro and Ruawaro and head onto Naike on Hwy 22, approximately 24.4km.
- Pass Thundercross Valley Dirt Bike Park, then turn left onto Waikaretu Valley Road approximately 10.3km. Continue on this road past Nikau Caves & Café for approximately 19km.
- Turn right onto Port Waikato Waikaretu Road. Travel approx 7.8kms, then turn left at Baker Road and continue on Port Waikato Waikaretu Road. Travel approx 13kms until you get to the woolsheds and turn left into the service area.

Directions: Sunday

Directions from Tuakau

- Travel to Tuakau township. Continue on River Road then turn off at Tuakau Bridge-Port Waikato Road.
- Travel around 25kms until you get to Port Waikato then continue on to Port Waikato- Waikaretu Road. Travel approx 14kms, Limestone Downs Road will be on your right.
- Continue on Port Waikato-Waikaretu Road for approximately 390 meters and pit entry will be on your right. Please take care as you will be driving through the finish and we may have people setting up.

Directions from Huntly

- Cross the bridge at Huntly and travel along Heatherington Road, pass through Rotongaro and Ruawaro and head onto Naike on Hwy 22, approximately 24.4km.
- Pass Thundercross Valley Dirt Bike Park, then turn left onto Waikaretu Valley Road approximately 10.3km. Continue on this road past Nikau Caves & Café for approximately 19km.
- Turn right onto Port Waikato Waikaretu Road. Travel approx 7.8kms, then turn left at Baker Road and continue on Port Waikato Waikaretu Road to Limestone Downs Road, approx 4.4km. Entry to the pit paddock will be on your left.
- Please be aware that there will be marshals setting up the event so please drive carefully.
